All nominees may submit to the Commission Chairman prior to 4:00 PM on February 17, 2023 a statement for inclusion on the ballot containing no more than thirty-five (35) words, which statement shall contain biographical information and/or a statement concerning the nominee's position on one or more issues pertinent to the Louisiana Deferred Compensation Plan.

The ballots, envelopes, and signature slips needed by participants desiring to cast a vote in the election for a participant member of the Deferred Compensation Commission will be mailed to each participant on or before April 30, 2023. The deadline for returning ballots is 4:00 PM on June 2, 2023 when Duplantier, Hrapmann, Hogan & Maher, LLP will conduct the ballot count. The results of the election will be reported to the Commission Chairman and presented at the June 2023 Commission Meeting.
