RESPONSIBILITIES: The primary responsibility of this position is to assist MSTC instructors during the practical training exercises where additional instructional personnel are needed to meet the student to instructor safety ratios. The position requires knowledge in training of marine safety including, but not restricted to, sea survival, enclosed lifeboats, HUET, and firefighting. The candidate will be required to maintain instructional equipment and training aids.

QUALIFICATIONS: Experience in industrial training and curriculum development. Experience in the offshore oil industry or at sea experience in the military or merchant marine. Knowledge of marine survival equipment. Capable of qualifying as a lifeguard. Ship's Master/Mate license and scuba certification is a plus and a Minimum of Bachelor's degree is preferred.
